On May 20, Society vice president Jim Wojcik, treasurer Dave Redding, and I attended a free conference hosted by The Heinz History Center for its HCAP (History Center Affiliates Program) members. The daylong program covered historical costumes (for docents), building small exhibits on a budget, social media, fundraising, and collections care.

It was a great opportunity for us to be in a room filled with representatives from other small museums and history centers where we could share ideas and, most importantly, have experts answer our questions.

Although we have no plans to add docents in period costumes to the History Center, the session on costumes was fascinating, and we got ideas and contact information to help us with future events, such as a St. Clair Cemetery tour we plan to host next year—our hope is to have docents wear costumes relating to different periods of the community's past.

Representatives of the Jefferson Country Historical Society gave us a fascinating glimpse into their move from a small building to a much larger one and how they build great exhibits on a very limited budget. They also provided ideas on how to attract businesses and individuals to sponsor exhibits. I never knew we could inexpensively build our own Plexiglas display cases; now I can't wait to try.

We are already using Facebook to inform people about what we are doing and share history facts and photographs, but thanks to this session, I realized I'd been neglecting the events calendar feature.

Audrey Brourman of A.L. Brourman Assoc, a company that handles the Heinz History Center's fundraising/public relations, and Jeremy Burnworth, of the Fayette County Historical Society (with whom I went to the American Association of State and Local History conference September), conducted the fundraising last They discussed everything session. from grassroots efforts to building a database of supporters. This was a very informative session, as we will soon need to think about acquiring larger quarters-and larger quarters will require more funds

Jim Wojcik is our collections management chair, so the final session on collections care was extremely useful to him. For the session, we visited the Heinz History Center's collections processing room where we received an overview on what supplies we should have on hand that will best preserve our treasures.

In all, it was a great day filled with ideas we can implement to make our center the best it can be. Many times the panelists suggested things that we are already doing, which made us feel great and super smart. Other suggestions provided "A-ha" moments—including hosting a member appreciation event, which we plan to hold later this summer or early fall.

We thank the Heinz History Center for sponsoring this event and making it so reasonably priced (I did mention it was free, didn't I?).

A SAD ANNOUNCEMENT

After 86 years of serving the community, the Mt. Lebanon Woman's Club has disbanded. The club-that once owned a clubhouse designed by Ingham and Boyd on Hollycrest Drive-was a philanthropic organization and an active force behind the creation of several local institutions, including the Mt. Lebanon Public Library. At its peak in the 1960s, the club had 1,400 members, and membership was so prestigious that prospective members needed two sponsors to be accepted. The club has already presented the Society with a gavel-created from the Cedar of Lebanon trees that gave the community its nameas well as a framed letter of the club's corporation filing dated March 20, 1930. Those items are displayed prominently at the History Center, and we have been told additional records may be donated to the Society's collection. In June, the Woman's Club presented a \$150 gift to the Society in recognition of Jane Morton, who served as the club's president from 2008 until it disbanded in June. We would like to thank the club for its gift and for entrusting its wonderful, irreplaceable pieces of Mt. Lebanon's past to our care.

BOOK AWARD

Every year, The Historical Society of Mount Lebanon presents its History Book Prize to a Mt. Lebanon High School junior, selected by the high school's social studies teachers, as a way to recognize that student's passion for and interest in U.S. History and encourage future study of our nation's past. We also presented a copy of the book to the High School library in hopes of enlightening and edifying other students.

This year's recipient was **Nick Brown**. U.S. History Teacher Peter DiNardo says that Nick is an exceptionally bright, hardworking student as well as a nice, decent, and honest person. Although Dinardo feels Nick is destined for a career in science and math, he says Nick dedicates himself passionately to the study of U.S. History, giving time, attention to detail, and consideration to each and every assignment. Nick enjoys being challenged and, in class, will guide discussions, weaving in quieter students.

The book we presented was "Andrew Jackson: His Life and Times" by H.W. Brands. Dinardo suggested the book as Nick had used this complex and controversial United States president as a topic of debate.

We congratulate this fine young man and outstanding scholar. It was our privilege to award him with the 2011 Historical Society of Mount Lebanon History Book Prize.

September 28 - We will meet at the Baptist Homes on Castle Shannon Boulevard to hear a talk and see pictures of this 100-year-old facility that started as an orphanage and home for the aged.

November 2 - Former Mt. Lebanon High School teacher John Canning and chief archivist of the Heinz History Center David Grinnell, will present a talk about the Thaw family. William Thaw was a Pittsburgh coal and railroad baron in

the 1800s. Son Harry, however, may have eclipsed the family's philanthropic endeavors by killing architect Stanford White for the love of Evelyn Nesbit, better known as the Girl in the Red Velvet Swing (her mother lived in Mt. Lebanon).

January 18, 2012 - A very special program will be held at Temple Emanuel on Bower Hill Road for a viewing of a Nova documentary about history and the Bible. **Ron Tappy**, of the Pittsburgh Theological Seminary, will be the guest speaker. We thank former board member Barbara Logan for her work in arranging this event.

WALKING TOURS & OTHER EVENTS

Our summer walking tours have been very well received and our June tour of St. Bernard and Mt. Lebanon United Presbyterian churches drew a large crowd. Look for an article about the church tour in an upcoming **Suburban Living magazine**, which is part of the weekly Almanac paper. If you haven't had a chance to attend one of our tours, you still have time.

At 10 a.m., Saturdays, July 9, September 10, and October 8, we will host 90-minute **tours of Washington Road** beginning at the Mt. Lebanon History Center (200 Lebanon Avenue—across from Southminster Church). The tours will proceed from the Center down Washington Road to Rolliers and back. Along the way, the history of Mt. Lebanon's central business district will be discussed, old pictures shown, and architectural details pointed out (find out where the owl and the eagle are on Washington Road!) The tour includes the inside of the Art Deco municipal building.

At 10 a.m., Friday, August 12, tour goers will meet in the Mt. Lebanon United Presbyterian Church parking lot (under the "drive-thru" arch) for **"Stains & Stained Glass" tours** of the nearly 100-year-old **St. Bernard Church** with the Spanish tile roof and beautiful frescos and **Mt. Lebanon United Presbyterian Church**—Mt. Lebanon's oldest (and first) church. The tours will cover the history of the churches with a primary focus on the stained glass windows. Tours are \$5 for members; \$10 for nonmembers. Please call 412-563-1941 to make a reservation. ARCADIA BOOK

CONSTITUTION CHANGES

According to the Society's Constitution, any changes to said Constitution must be advertised to the membership at least 60 days prior to the vote at the annual meeting in November. The following proposed amendments were initiated and passed by a two-thirds majority vote at the June 8, 2011 Board of Trustees meeting. These amendments will not be adopted or go into effect until they are approved by a two-thirds majority vote by the membership present and qualified to vote at the Society's annual meeting in November of this year. All remaining sections of the Constitution remain as currently adopted. Words to be removed or deleted from the current Constitution are identified with a cross thru Words added from the current Constitution are identified in **boldface type**.

Article III – MEMBERSHIP

Section 4: The membership of the Society shall hold an annual meeting on a date established by the Board of Trustees and announced to the membership in writing. At this meeting members will receive the reports of the various officers of the Society, and members in good standing at the time of the meeting shall elect trustees for the coming year and conduct any other business brought before the assembly. A quorum to conduct business at the annual meeting shall consist of a majority of members

present who are qualified to vote - minimum of 10 members present and in good standing.

Article IV – BOARD OF TRUSTEES

Section 3. Election of trustees shall occur at the Society's annual meeting from a slate of candidates prepared by a Nominating Committee named by the Board of Trustees and chaired by the Board Vice-President. Candidates may also be nominated from the floor provided their nomination is moved and seconded by at least two members-in-good-standing different of the Society. The term of each trustee shall begin on January 1 immediately following election.... Members of the Board of Trustees can serve no more than two consecutive three-year terms in succession. However, nothing shall prevent a former Board of Trustee Member from being nominated and then serving on the Board after a year's absence.

<u>Section 4:</u> The Board of Trustees shall meet bi-monthly at least 5 times annually at the Mount Lebanon Public Library or other convenient location to conduct the business of the Society. A quorum, consisting of a majority of the Trustees then sitting on the Board, shall be necessary for the Board to conduct business. The <u>Secretary</u> **President** of the Board shall give trustees ten (10) **no fewer than five (5)** days written notice, including the place and time, for each regular meeting.

Article V – COMMITTEES

Section 4: A Nominating Committee shall be appointed for a term of one (1) year and shall be chaired by the Vice-President of the Board of Trustees. This committee shall 1) make recommendations for filling vacancies between elections and 2) compile slates of candidates for election as trustee and officers of the Society for presentation at the appropriate meetings. No later than sixty (60) days prior to the annual meeting, the Nominating Committee shall invite members to submit names and brief resumes of possible candidates who would be willing to serve as officers or trustees. The Nominating Committee shall review these recommendations and exercise its best judgment in compiling a list of candidates from these and other sources. The proposed slate(s), with supporting biographies, shall be distributed made available to the membership no less than seven (7) days prior to the annual meeting.

HISTORY TIDBIT

This is an excerpt from an old newspaper article dated <u>March 2, 1923</u>. The entire article is in the Society's collection.

BIBLES GIVEN AT NEW MT. LEBANON SCHOOL

A color guard and a guard of honor for every public school were asked for last Thursday by William T. Kerr, president of the American Flag Association, in his Washington's Birthday address to teachers and pupils of the newly erected public school of Mt. Lebanon [Washington Elementary], when he presented a large flag and 15 Bibles on behalf of Castle Shannon council 297, Fraternal Patriotic Americans....

Just as Mr. Kerr finished presenting the flag and Bibles, four whitehooded Ku Klux Klansmen marched down the auditorium aisle to the stage and handed a flag and a letter to the speaker, who said he was taken by surprise.

The letter said, "We present this flag as a token that we as a body of Christian American men stand four square behind the public schools."

It was signed, "Pittsburgh Provisional Klan No. 5, Realm of Pennsylvania Invisible Empire Knights of the Ku Klux Klan"...

Robert Kelly, president of the school board, accepted the flag and Bibles from the patriotic Americans, but left the acceptance of the Ku Klux Klan flag to the audience, which approved. The Klansmen came to the school in automobiles and disappeared on delivery of the flag and letter.

Let us hope they disappeared for good and were never heard from again.
